

DD15 ASSESSMENTS AND DD15 COMMON OUTLET ASSESSMENTS TO DD94 AND DD16

The following is a guide to determine the total assessment your individual parcel(s) will receive after the completion of a drainage ditch project. The following information is needed in order to determine an individual parcels assessment: Total Assessment Units, Individual Parcel Assessment Units and Projected Levy Amount. It is also helpful to know your parcel PIN as the assessment schedule are listed in numerical order by PIN. However, the landowner as of December 4, 2020, is also listed along with the parcel's legal description. The following dollar amounts for each schedule are based upon estimated levies.

Project Levy Summary:

Drainage District No. 15, Main Open Ditch

- \$379,000.00 Levy
- 100,000 Assessment Units

Drainage District No. 15, Main Tile

- \$61,000.00 Levy
- 1,000,000 Assessment Units

Drainage District No. 15, Lateral A Open Ditch

- \$274,000.00 Levy
- 100,00 Assessment Units

Drainage District No. 15, Upper Main Open Ditch

- \$82,400.00 Levy
- 10,000 Assessment Units

Drainage District No. 94, Common Outlet Assessment

- \$44,565.18 Common Outlet
- 100,000 Assessment Units

Drainage District No. 16, Common Outlet Assessment

- \$38,455.44 Common Outlet
- 6,000 Assessment Units

Calculation Example

$$\frac{\text{Parcel Assessment Units}}{\text{Total Assessment Units}} \times \text{Project Levy (\$)} = \text{Parcel Levy (\$)}$$

Example for City of Eagle Grove Roads (PIN 101) (Parcel PIN will be 10-digits)

Drainage District No. 15, Main Open Ditch

$$\frac{11,472.16}{100,000.00} \times \$379,000.00 = \$43,479.49$$

Drainage District No. 15, Lateral A Open Ditch

$$\frac{2,591.90}{100,000.00} \times \$274,000.00 = \$7,101.81$$

Drainage District No. 15, Main Tile

$$\frac{90,682.02}{1,000,000.00} \times \$61,000.00 = \$5,531.60$$

Drainage District No. 15, Upper Main Open Ditch

$$\frac{289.12}{10,000.00} \times \$82,400.00 = \$2,382.35$$

$$\text{City of Eagle Grove Roads} = \$43,479.49 + \$7,101.81 + \$5,531.60 + \$2,382.35 = \$58,495.25$$

A parcel could be contained in all or one of the Drainage District No. 15 facilities.

The Common Outlet Assessment is the amount charged by DD15 to DD16 or DD94 for their use and benefit of the DD15 Main Open Ditch.
