

ORDINANCE NO. 2018-11

**AN ORDINANCE ADOPTING THE “CODE OF ORDINANCES
OF THE CITY OF EAGLE GROVE, IOWA”**

BE IT ORDAINED by the City Council of the City of Eagle Grove, Iowa, that:

SECTION 1. Pursuant to published notice and following public hearing on the 2nd day of July, 2018, so required by Sections 362.3 and 380.8, Code of Iowa, there is hereby adopted by the City of Eagle Grove, Iowa, the “CODE OF ORDINANCES OF THE CITY OF EAGLE GROVE, IOWA.”

SECTION 2. All of the provisions of the “CODE OF ORDINANCES OF THE CITY OF EAGLE GROVE, IOWA,” shall be in force and effect on and after the effective date of this ordinance.

SECTION 3. All ordinances or parts thereof in force on the effective date of this ordinance are hereby repealed from and after the effective date of this ordinance, except as hereinafter provided.

SECTION 4. The repeal provided for in the preceding section of this ordinance shall not affect any offense or act committed or done or any penalty or forfeiture incurred or any contract or right established or accruing before the effective date of this ordinance; nor shall such repeal affect any ordinance or resolution promising or guaranteeing the payment of money by the City or authorizing the issuance of any bonds of said City or any evidence of said City's indebtedness or any contract or obligation assumed by said City; nor shall said repeal affect the administrative ordinances or resolutions of the Council not in conflict or inconsistent with the provisions of “THE CODE OF ORDINANCES OF THE CITY OF EAGLE GROVE, IOWA”; nor shall it affect the following ordinances specifically saved from repeal:
