

ORDINANCE NO. 2024-15

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF EAGLE GROVE, IOWA, BY AMENDING PROVISIONS PERTAINING TO COMPENSATION

Be It Enacted by the City Council of the City of Eagle Grove, Iowa:

SECTION 1. SECTION MODIFIED. Section 15.04 of the Code of Ordinances of the City of Eagle Grove, Iowa, is repealed and the following adopted in lieu thereof:

15.04 COMPENSATION. The salary of the Mayor is \$7,500.00 per year.

(Code of Iowa, Sec. 372.13[8])

SECTION 2. SECTION MODIFIED. Section 17.06 of the Code of Ordinances of the City of Eagle Grove, Iowa, is repealed and the following adopted in lieu thereof:

17.06 COMPENSATION. The salary of each Council member is \$100.00 for each Council meeting attended.

(Code of Iowa, Sec. 372.13[8])


SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

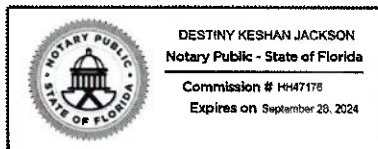
