### Resolution 2021-25

#### A RESOLUTION SETTING A DATE FOR PUBLIC HEARING TO CONSIDER A VOLUNTARY ANNEXATION APPLICATION

**WHEREAS**, the City of Eagle Grove, Iowa, has received a Voluntary Petition for Annexation of certain real estate into the City of Eagle Grove, Iowa; a copy of which is attached hereto and by this reference is made a part hereof, and ;

**WHEREAS**, the City Clerk is required to prepare and deliver Statutorily Required Notices to the Board of Supervisors of Wright County and the Trustees of Eagle Grove Township setting the date, time and location for a consultation with said person pursuant to Iowa Code Section 368.7(b)(1), and;

**WHEREAS**, Iowa Code Section 368.7 requires a copy of the application to also be mailed by certified mail to each affected public utility at least fourteen (14) business days prior to any action taken by the City Council on the Application, and;

**WHEREAS**, the City Clerk is also to publish Notice of the date and time of Hearing on the Application.

All that part of the East ½ of the NW ¼ of Section 22, Township 91 North, Range 26 West of the 5<sup>th</sup> P.M., Wright County, Iowa, lying West of the Railroad right-of-way and East of Highway No. 17 (formerly No. 60)

**NOW, THEREFORE, BE IT RESOLVED**, that:

1. The City Council of the City of Eagle Grove, Iowa, pursuant to Chapter 368.7(d) will hold a public hearing on the application for annexation and zoning on the 7<sup>th</sup> day of June, 2021 at 6:30 p.m. at the Eagle Grove City Hall Council Chambers, located at 210 E. Broadway, Eagle Grove, IA 50533.
2. The annexation proposed is entirely voluntary; therefore, there are no non-consenting owners.
3. The City Clerk shall do as follows: Prepare and deliver Notices to the Board of Supervisors of Wright County and the Trustees of Eagle Grove Township setting the date, time and location for a consultation with said person pursuant to Iowa Code Section 368.7(b)(1); to include with such Notices, a Waiver to be signed in lieu of the consultation; to send a Certified Mailing of the Application to each affected public utility at least fourteen (14) business days prior to June 7, 2021; and to publish notice of the application in an official County newspaper.
4. The City Council of the City of Eagle Grove shall approve or deny the Application by duly adopting a Resolution after the hearing on said date and time.
