RESOLUTION 2021-33
RESOLUTION APPROVING FY 2022 SALARIES AND WAGES FOR THE CITY OF
EAGLE GROVE, IOWA

Whereas, the City Council of the City of Eagle Grove, Iowa, subject to the Municipal Code of Ordinances Chapter 17.02(6) shall authorize, by resolution, the compensation of employees or officers.

THEREFORE, BE IT RESOLVED, that the City Council of the City of Eagle Grove, Iowa hereby authorizes the following salaries and wages for appointed officers and employees for the City of Eagle Grove for Fiscal Year 2021-2022.

Section 1. The following persons and positions shall be paid the bi-weekly salaries or hourly wages as defined.

Section 2. The City Finance Officer is hereby authorized to issue compensation less legally required, or authorized, deductions from the amounts set out below.

Section 3. Payroll intervals, overtime provisions, and other related payroll personnel procedures shall be conducted in the manners prescribed in the City of Eagle Grove Personnel Policy, applicable Collective Bargaining Agreements, and the Fair Labor Standard Act.

Section 4. The pay rates below are hereby effective July 1, 2021.

Section 5. Pay rates for qualifying Law Enforcement Personnel shall follow the Agreement between the City of Eagle Grove and the International Brotherhood of Teamsters, Local 238. Pay rates for qualifying Public Works Personnel shall follow the Agreement between the City of Eagle Grove and the International Union of Operating Engineers, Local 234. The City Council for the City of Eagle Grove has approved and authorized compensation adjustments per the applicable Agreements between the City of Eagle Grove and the International Brotherhood of Teamsters, Local 238 and the International Union of Operating Engineers, Local 234 and said Agreements shall be followed.

Section 6. The City Administrator shall receive a one-time pay adjustment of \$3,000 payable at the first official pay period beginning Fiscal Year 2021-2022.


Section 7. All resolutions or parts thereof in conflict herewith are hereby repealed, to the extent of such conflict.

AYES: Pamperin, Weland, Middleton, and Quintus


