RESOLUTION TO SET A DATE FOR PUBLIC HEARING TO CONSIDER THE 2022
STREET IMPROVEMENT PROJECT

WHEREAS, the City of Eagle Grove (the "City"), in Wright County, State of Iowa, calls for a public hearing to consider the 2022 Street Improvement Project, and to give notice thereof as required by such law, including notice of the right to petition for an election on such proposal, and;

WHEREAS, the City of Eagle Grove City Council shall hear comments, both orally and written, for the consideration and action on a potential street improvement project for the 2022 construction season, and;

WHEREAS, this public hearing will be to consider different roadways within the City of Eagle Grove and to consider moving forward with a project in the 2022 construction season, and;

NOW, THEREFORE, Be It Resolved by the City Council of the City of Eagle Grove, Iowa, as follows:

Section 1. This City Council shall meet on August 16, 2021, at the Eagle Grove City Hall Council Chambers, Eagle Grove, Iowa, at 6:30 p.m., at which time and place a hearing will be held and proceedings will be instituted and action taken to move forward with a 2022 Street Improvement Project described in the preamble hereof.

Section 2. The City Clerk is hereby directed to give notice of the proposed action setting forth the amount and purpose thereof, the time when and place where the said meeting will be held by publication at least once, not less than ten (4) and not more than twenty (20) days before the date of said meeting, in a legal newspaper which has a general circulation in the City.

PUBLIC HEARING NOTICE

The City of Eagle Grove, Iowa, is hereby serving as Public Notice that on August 16, 2021, at 6:30 p.m., the City Council will hold a public hearing at City Hall to consider a 2022 Street Improvement Project. The Hearing will allow citizens the opportunity to provide opinions and comments, both verbal and written, for the Council. The proposed 2022 Street Improvement Project may result in the rehabilitation/reconstruction of a roadway, infrastructure improvements, amenity improvements, and other improvements necessary for the completion of the project and the betterment of the community.


This meeting will be held to give residents information concerning a proposed project. Citizens are encouraged to attend and express their preferences about the proposed activities. Anyone having questions about this project, or if you require special accommodations to attend the Hearing such as handicapped accessibility or translation services, you may contact City Hall at 515-448-4343.
