**A RESOLUTION SUPPORTING AN ELECTRONIC SIGN AND PROVIDING ASSISTANCE IN THE CITY OF EAGLE GROVE**

**WHEREAS**, the City Council of the City of Eagle Grove support the installation and use of an electronic sign for the community, and

**WHEREAS**, the City Council of the City of Eagle Grove feel it to be in the best interest to aid in the purchase and installation of an electronic sign in the City of Eagle Grove for community use, and

**NOW THEREFORE BE IT RESOLVED** that the City Council of Eagle Grove, Iowa hereby approve and authorize the grant with respect to the following stipulations.

Section 1. A grant of \$15,000 shall be provided upon substantial completion of the installation of the electronic sign pending the rest of this Resolution has been followed.

Section 2. The City Council shall execute a Service Agreement with the entity tasked with purchasing, installing, and/or operating the electronic sign.

Section 3. The grant shall automatically be considered invalid and shall not be disbursed should the electronic sign not be purchased for installation on or before December 31, 2022.
