**A RESOLUTION SETTING THE TIME AND PLACE OF A PUBLIC HEARING
ON THE SUBMISSION OF A CDBG APPLICATION FOR THE

WHEREAS, the City Council of the City of Eagle Grove, Iowa desires to apply for Community Development Block Grant funding from the Iowa Economic Development Authority, and

WHEREAS, the City has a need to make improvements to the City's wastewater collection system, specifically the replacement of the Highway 17 Lift Station to resolve impacts of flooding within the sewershed, and

WHEREAS, the requirements of the CDBG application require the City to hold a public hearing to allow citizens the opportunity to be heard and provide comments on the submission of a grant application;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF EAGLE GROVE, IOWA, that a public hearing be conducted by the City Council in the Council Chambers, located in City Hall at 210 E. Broadway, Eagle Grove, Iowa on Monday, November 7, 2022 at 6:30 p.m.

BE IT FURTHER RESOLVED, that the City Clerk shall give notice of said public hearing by publication of a notice in the Eagle Grove Eagle at least once, not less than four and not more than 20 days before the meeting.
