WHEREAS, the requirements of the CDBG application require the City to hold a public hearing to allow citizens the opportunity to be heard and provide comments on the submission of a grant application;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF EAGLE GROVE, IOWA, that a public hearing be conducted by the City Council in the Council Chambers, located in City Hall at 210 E. Broadway, Eagle Grove, Iowa on Monday, April 25, 2022 at 6:30 p.m.

BE IT FURTHER RESOLVED, that the City Clerk shall give notice of said public hearing by publication of a notice in the Eagle Grove Eagle at least once, not less than four and not more than 20 days before the meeting.


