RESOLUTION SETTING SALARIES FOR FISCAL YEAR 17-18 FOR THE APPOINTED OFFICERS AND EMPLOYEES FOR THE CITY OF EAGLE GROVE

Be it hereby resolved that the Council of the City of Eagle Grove, Iowa that:

Section 1. The following persons and positions shall be paid the bi-weekly salaries or wages indicated.

Section 2. The City Finance Officer is authorized to issue checks, less legally required or authorized deductions from the amounts set out below.

Section 3. Payroll intervals, overtime provisions, and other related payroll personnel procedures shall be conducted in the manners prescribed in the City of Eagle Grove Personnel Policy and the Fair Labor Standard Act.
