**RESOLUTION TO SET A DATE FOR PUBLIC HEARING TO
CONSIDER THE SUBMISSION OF A CDBG GRANT APPLICATION
FOR EAGLE'S WINGS PRESCHOOL AND CHILDCARE FACILITY**

WHEREAS, the City of Eagle Grove (the "City"), in Wright County, State of Iowa, calls for a public hearing to consider the submission of a Community Development Block Grant (CDBG) Application for the renovation and expansion of the Eagle's Wings Preschool and Childcare Facility and to give notice thereof as required by such law, including notice of the right to petition for an election on such proposal, and;

WHEREAS, the grant application will request funding assistance for the renovation and expansion of the Eagle's Wings Preschool and Childcare Facility, and;

WHEREAS, the City of Eagle Grove City Council shall hear comments, both orally and written, for the consideration of the CDBG Community Facilities Grant Application and the meeting will be held at the time and place defined hereto concerning the proposed project;

NOW, THEREFORE, Be It Resolved by the City Council of the City of Eagle Grove, Iowa, as follows:

Section 1. This City Council shall meet on December 16, 2019, at the Eagle Grove City Hall Council Chambers, Eagle Grove, Iowa, at 6:30 p.m., at which time and place a hearing will be held and proceedings will be instituted and action taken to submit the CDBG Community Facilities Grant Application described in the preamble hereof.

Section 2. The City Clerk is hereby directed to give notice of the proposed action on the submission of the Opportunities & Threats Grant Application setting forth the amount and purpose thereof, the time when and place where the said meeting will be held by publication at least once, not less than ten (4) and not more than twenty (20) days before the date of said meeting, in a legal newspaper which has a general circulation in the City. The notice shall be in substantially the following form:

PUBLIC HEARING NOTICE

The City of Eagle Grove, Iowa, is hereby serving as Public Notice that on December 16, 2019, at 6:30 p.m., the City Council will hold a public hearing at City Hall, 210 E. Broadway, to consider the submission of an application for a Community Development Block Grant for the renovation and expansion of the Eagle's Wings Preschool and Childcare Facility.


