

RESOLUTION 2019-120

RESOLUTION SETTING DATE FOR PUBLIC HEARING TO REVIEW PLANS,
SPECIFICATIONS, AND BID DOCUMENTS FOR THE 2020 STREET IMPROVEMENT
PROJECT

WHEREAS, the City of Eagle Grove (the "City"), in Wright County, State of Iowa, calls for a public hearing to consider and review plans, specifications, and bid documents for planned roadway projects thereof as required by such law, including notice of the right to petition for an election on such proposal;

WHEREAS, the City Council for the City of Eagle Grove would like to set the date of public hearing to Monday, January 20, 2020 and provide such notice thereof as required by such law, including notice of the right to petition for an election on such proposal;

WHEREAS, the City of Eagle Grove City Council shall on Monday, January 20, 2020 hear comments, both orally and written, for the consideration and review of the roadway project and the meeting will be held at the time and place defined hereto concerning the proposed project;

NOW, THEREFORE, Be It Resolved by the City Council of the City of Eagle Grove, Iowa, as follows:

Section 1. This City Council shall meet on January 20, 2020, at the Eagle Grove City Hall Council Chambers, Eagle Grove, Iowa, at 6:30 p.m., at which time and place a hearing will be held and proceedings will be instituted and action taken to approve of the plans, specifications, and bid documents for the 2020 Street Improvement Project described in the preamble hereof.

Section 2. The City Clerk is hereby directed to give notice of the proposed action setting forth the amount and purpose thereof, the time when and place where the said meeting will be held by publication at least once, not less than ten (4) and not more than twenty (20) days before the date of said meeting, in a legal newspaper which has a general circulation in the City. The notice shall be in substantially the following form:

Notice is hereby given that the City Council of Eagle Grove, Iowa, will meet at City Hall, 210 E Broadway Street, Eagle Grove, Iowa on the **20th day of JANUARY, 2020, at 6:30 p.m.**, at which time and place a hearing will be held on the proposed plans and specifications, form of contract and estimate of cost for 2020 Street Improvement Project in and for said City. Any interested person may appear at said hearing and file objections to the proposed plans, specifications, form of contract and estimated costs for said improvements.

The project is located in Eagle Grove, Iowa taking place on SW 2nd Street, commencing at the intersection of S. Iowa Avenue and traversing West until the intersection with S. Lincoln Avenue. Project also includes SW 4th Street from S. Commercial Avenue heading East to S. Park Avenue.

The general description of types of construction and limits for which bids will be received shall be as follows:

Reconstruction of roadway on SW 2nd Street and SW 4th Street with subgrade preparation, crushed stone subbase, and 6-inch-thick asphalt roadway. The surface on SW 2nd Street and SW 4th Street will also be milled and overlaid with asphalt. Work also includes driveway tie-ins, minor grading, intake and manhole adjustments, and all other miscellaneous work to complete the project.

Plans and specifications governing the construction of the proposed improvements have been prepared by the Engineer. These plans and specifications, and the proceedings of the City referring to and defining said improvements, are hereby made a part of this Notice and the proposed contract by reference, and the proposed contract shall be executed to comply therewith.
