RESOLUTION NO. 2019-33

Resolution setting the date for public hearing to consider the submission of a Housing Fund Application

WHEREAS, the City of Eagle Grove (the "City"), in Wright County, State of Iowa, calls for a public hearing to consider the submission of a Housing Fund Application and to give notice thereof as required by such law, including notice of the right to petition for an election on such proposal;

WHEREAS, the grant application will request funding assistance for an owner-occupied housing rehabilitation program in a target neighborhood;

WHEREAS, the City of Eagle Grove City Council shall hear comments, both orally and written, for the consideration of the Housing Fund Application and the meeting will be held at the time and place defined hereto concerning the proposed project;

NOW, THEREFORE, Be It Resolved by the City Council of the City of Eagle Grove, Iowa, as follows:


Section 1. This City Council shall meet on April 15, 2019, at the Eagle Grove City Hall Council Chambers, Eagle Grove, Iowa, at 6:30 p.m., at which time and place a hearing will be held and proceedings will be instituted and action taken to submit the Housing Fund Application described in the preamble hereof.

Section 2. The City Clerk is hereby directed to give notice of the proposed action on the submission of the Housing Fund Application setting forth the amount and purpose thereof, the time when and place where the said meeting will be held by publication at least once, not less than ten (4) and not more than twenty (20) days before the date of said meeting, in a legal newspaper which has a general circulation in the City. The notice shall be in substantially the following form:

Section 3. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

Section 4. This resolution shall be in full force and effect immediately upon its adoption and approval, as provided by law.
