

SET DATE FOR HEARING ON URBAN RENEWAL PLAN AMENDMENT

The City Council of the City of Eagle Grove, Iowa, met on August 19, 2019, at 6:30, p.m., at the Eagle Grove City Hall Council Chambers, in the City, for the purpose of setting a date for a public hearing on a proposed urban renewal plan amendment. The Mayor presided and the roll being called, the following members of the City Council were present and absent:

The Mayor announced that an amendment to the urban renewal plan for the Eagle Grove Urban Renewal Area had been prepared, and that it was now necessary to set a date for a public hearing on the proposed amendment to the urban renewal plan. Accordingly, Council Member Schild moved the adoption of the following resolution entitled "Resolution Setting Date for a Public Hearing on Urban Renewal Plan Amendment," and the motion was seconded by Council Member Weland. Following due consideration, the Mayor put the question on the motion and the roll being called, the following named Council Members voted:

Whereupon, the Mayor declared the resolution duly adopted as follows:

RESOLUTION NO. 2019-71

Resolution Setting Date for Public Hearing on Urban Renewal Plan Amendment

WHEREAS, the City Council of the City of Eagle Grove, Iowa by resolution previously established the Eagle Grove Urban Renewal Area (the "Urban Renewal Area") and adopted an urban renewal plan (the "Plan") for the governance of initiatives and projects therein; and

WHEREAS, an amendment (the "Amendment") to the Plan has been prepared which authorizes the undertaking of new urban renewal projects in the Urban Renewal Area consisting of (1) using tax increment financing to pay the costs of the City's Downtown Façade Rehabilitation Program; (2) providing tax increment financing support to Gold Eagle Cooperative (the "Coop") in connection with the construction of a new maintenance shop for use in the Coop's agribusiness operations; and (3) using tax increment financing to fund an economic development grant to Eagle Grove Hotel, LLC in connection with the construction of a hotel, and it is now necessary that a date be set for a public hearing on the Amendment;


NOW, THEREFORE, Be It Resolved by the City Council of the City of Eagle Grove, Iowa, as follows:

Section 1. This City Council will meet at the Eagle Grove City Hall Council Chambers, in Eagle Grove, Iowa, on September 23, 2019, at 6:30 p.m., at which time and place it will hold a public hearing on the proposed Amendment.



The City Clerk shall publish notice of said hearing, the same being in the form attached hereto, which publication shall be made in a legal newspaper of general circulation in the City, which publication shall be not less than four (4) and not more than twenty (20) days before the date set for hearing.

Section 3. Pursuant to Section 403.5 of the Code of Iowa, the City Administrator is hereby designated as the City's representative in connection with the consultation process which is required under that section of the urban renewal law.
