

RESOLUTION 2020-56

**A RESOLUTION TO SET A DATE FOR PUBLIC HEARING FOR THE VACATION AND CONVEYANCE OF PUBLIC RIGHT-OF-WAY AS PLATTED IN BLOCK 15, WRIGHT'S 3<sup>RD</sup> ADDITION, WRIGHT COUNTY, IOWA, MORE FORMALLY KNOWN AS 7<sup>TH</sup> STREET NW**

**WHEREAS**, on October 2, 2020, the City Council received a request to vacate and convey public right-of-way measuring approximately 99' by 129' in Block 15, Wright's 3<sup>rd</sup> Addition, Wright County, Iowa; and,

**WHEREAS**, Gold-Eagle Cooperative, the owner of the real property which abuts said public right-of-way, submitted the request to vacate and convey the public right-of-way; and,

**WHEREAS**, there is no known current or future public need or benefit for the alley proposed to be vacated and conveyed and, therefore, its maintenance at public expense is no longer justified, and the proposed vacation and conveyance will not deny owners of property abutting the alley reasonable access to their property; and,

**WHEREAS**, it is in the best interest of the City to set a hearing for the vacation and conveyance of the aforementioned alleyway and to provide an opportunity for further consideration of the public and the Planning & Zoning Commission; and,

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Eagle Grove, Iowa:


1. That the City Council shall require a recommendation from the Eagle Grove Planning & Zoning Commission prior to the consideration of an ordinance to permanently vacate the aforementioned public right-of-way.
2. That the City Council of the City of Eagle Grove shall consider adoption of an ordinance permanently vacating the West-East 7<sup>th</sup> Street NW from Commercial Avenue to final point of the public right-of-way in Block 15 of Wright's 3<sup>rd</sup> Addition in the City of Eagle Grove.
3. NOTICE IS FURTHER GIVEN, that the City Council will consider the adoption of the proposed vacation ordinance and approval of the proposed conveyance after a public hearing to be held at seven (7:00) p.m. in the Council Chambers in City Hall located at 210 East Broadway Street, Eagle Grove, Iowa on Monday, November 9, 2020
