The City Council of the City of Eagle Grove, Iowa met on February 3, 2025, at 6:30 p.m. at the Council Chambers, 210 E. Broadway, Eagle Grove, Iowa.

The Mayor presided and the roll being called, the following named Council Members were present and absent:

RESOLUTION NO. 2025-13

Resolution taking additional action on proposal to enter into a General Obligation Corporate Purpose Loan Agreement

WHEREAS, the City of Eagle Grove (the "City"), in Wright County, State of Iowa, heretofore proposed to enter into a General Obligation Corporate Purpose Loan Agreement (the "Loan Agreement") and to borrow money thereunder in a principal amount not to exceed \$350,000, pursuant to the provisions of Section 384.24A of the Code of Iowa, for the purpose of paying the cost, to that extent, of acquiring vehicles and equipment for the municipal sanitary sewer utility, waterworks utility and public works/street department; and pursuant to law and a notice duly published, the City Council has held a public hearing on such proposal on February 3, 2025;


NOW, THEREFORE, Be It Resolved by the City Council of the City of Eagle Grove, Iowa, as follows:

Section 1. The City Council hereby determines to enter into the Loan Agreement in the future and orders that General Obligation Corporate Purpose bonds or notes (the "Bonds") be issued at such time in evidence thereof. The City Council further declares that this resolution constitutes the "additional action" required by Section 384.24A of the Code of Iowa. Further action with respect to the Loan Agreement and the Bonds is hereby adjourned to the City Council meeting scheduled for February 17, 2025.

Section 2. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed to the extent of such conflict.

Section 3. This resolution shall be in full force and effect immediately upon its adoption and approval, as provided by law.
