

RESOLUTION NO. 2023-83

RESOLUTION TO SET A DATE FOR PUBLIC HEARING TO CONSIDER  
PLANS AND SPECIFICATIONS, FORM OF CONTRACT, AND THE 2024  
STREET IMPROVEMENT PROJECT

WHEREAS, the City of Eagle Grove (the "City"), in Wright County, State of Iowa, calls for a public hearing to consider the 2024 Street Improvement Project (the "Project") and to give notice thereof as required by such law, including notice of the right to petition for an election on such proposal;

WHEREAS, the City of Eagle Grove City Council shall hear comments, both orally and written, for the consideration of the 2024 Street Improvement Project and the meeting will be held at the time and place defined hereto concerning the proposed project;

NOW, THEREFORE, Be It Resolved by the City Council of the City of Eagle Grove, Iowa, as follows:

Section 1. This City Council shall meet on November 20, 2023, at the Eagle Grove City Hall Council Chambers, Eagle Grove, Iowa, at 6:30 p.m., at which time and place a hearing will be held and proceedings will be instituted and action taken to discuss and potentially define a 2024 Street Improvement Project described in the preamble hereof.

Section 2. The City Clerk is hereby directed to give notice of the proposed action setting forth the amount and purpose thereof, the time when and place where the said meeting will be held by publication at least once, not less than ten (4) and not more than twenty (20) days before the date of said meeting, in a legal newspaper which has a general circulation in the City. The notice shall be in substantially the following form:

**PUBLIC HEARING NOTICE**

The City of Eagle Grove, Iowa, is hereby serving as Public Notice that on November 20, 2023, at 6:30 p.m., the City Council will hold a public hearing at City Hall to consider the 2024 Street Improvement Project. The Project will consist of improving roadway and other critical infrastructure within the City of Eagle Grove. Such Project may result in general obligation of the City or financed in any way applicable under current law.

This meeting will be held to give residents information concerning the proposed Project. Citizens are encouraged to attend and express their preferences about the proposed activities. Anyone having questions about this project, or if you require special accommodations to attend the Hearing such as handicapped accessibility or translation services, you may contact City Hall at 515-448-4343.


