WITH FORT DODGE FIRE AND RESCUE**



TIER AGREEMENT

RE: Agreement to provide ALS Level Service to the City of Eagle Grove Ambulance Service.

As an Iowan licensed paramedic level service, Fort Dodge Fire Rescue will provide paramedic level tier services to the City of Eagle Grove Ambulance Service when requested or as available. The duration of this agreement shall be three years or 5/31/2027. Either party may terminate this agreement by giving at least 30 days written notice.

When Tier services are requested, Fort Dodge Fire Rescue personnel with appropriate equipment will board the City of Eagle Grove EMS unit and provide ALS services as needed.

In the event a tiered response is requested, the City of Eagle Grove Ambulance Service will bill for services to the patient and Fort Dodge Fire Rescue will bill the City of Eagle Grove for a tiered response. A tier fee payment of \$250 is due within 45 days of services rendered. Late payment can result in termination of this agreement.

To maintain this agreement, each party shall maintain insurance as required by law to cover all personnel, vehicles, and equipment.

The City of Eagle Grove Ambulance Service shall defend, indemnify, and hold harmless Fort Dodge Fire Rescue from and against all claims for bodily injury or property damage because of any acts, omissions, or negligence of the City of Eagle Grove Ambulance Service or any of its employees, officers, or agents.
